



4. Pre-bid meeting shall be held at Gharapjhong Rural Municipality, Office of the Rural Municipal Executive, Jomsom at 13:00 hrs on 2076/11/28 (March 11<sup>th</sup>, 2020)
5. Sealed or electronic bids must be submitted to the Gharapjhong Rural Municipality, Office of the Rural Municipal Executive, Jomsom by hand/courier or 12:00 hrs on 2076/12/13( **March 26<sup>th</sup>, 2020** ). Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 hrs. **And 2076/12/13(March 26<sup>th</sup>, 2020)** at the office of Gharapjhong Rural Municipality, Office of the Rural Municipal Executive, Jomsom. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a mentioned above bid Security, which shall be valid for 30 days beyond the validity period of the bid.
7. If the last date of purchasing and /or submission falls on government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
