4. Pre-bid meeting shall be held at Gharapjhong Rural Municipality, Office of the Rural Municipal Executive, Jomsom at 13:00 hrs on 2076/11/28 (March11th, 2020)

- 5. Sealed or electronic bids must be submitted to the Gharapihong Rural Municipality, Office of the Rural Municipal Executive, Jomsom by hand/courier or 12:00 hrs on 2076/12/13(March 26 th., 2020). Bids received after this deadline will be rejected.
- 6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 hrs. And 2076/12/13(March 26th, 2020) at the office of Gharapihong Rural Municipality, Office of the Rural Municipal Executive, Jomsom. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a mentioned above bid Security, which shall be valid for 30 days beyond the validity period of the bid.
