

5. Pre- bid meeting shall be held at Office of Gharapjhong Rural Municipal Executive Jomsom Mustang at 2080-06-16 (i.e. 03-10-2023) 13:00 hours.
6. Separate Electronic Bids for Contract identification Number must be submitted to the Office of Gharapjhong Rural Municipal Executive Jomsom Mustang through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 2080-06-25 (i.e. 12-10-2023) 13:00 hours.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2080-06-25 (i.e.12-10-2023) 13:00 hours at the Office of Gharapjhong Rural Municipal Executive Jomsom Mustang. Bids must be valid for a period of 90 days after bid opening. Bid Security amount must be



as per above table and shall be valid for 30 days beyond the bid validity period.
